Directions:

From South – Take Parkway North to exit 25(Ocean City) to Roosevelt Blvd., proceed over the bridge to 34th street, make a right turn onto West Ave. proceed south until the road ends, then make a left turn on 59th proceed to the parking lot area.

From North – Take Parkway South exit 25(Ocean City) to Roosevelt Blvd., proceed over the bridge to 34th street, make a right turn onto West Ave. proceed south until the road ends, then make a left turn on 59th proceed to the parking lot area.

From Atlantic City Expressway - Follow Atlantic City Expressway W and Garden State Pkwy South. Take exit 25 from Garden State Pkwy S, Take Roosevelt Blvd and West Ave to your destination in Ocean City

Equipment Drop off: For Authorized vehicles there will be a staff member to direct you at the beach entrance to the weigh in area. For unauthorized vehicles there will be staff to assist. For trailered boats there will be an area to leave them on the beach.



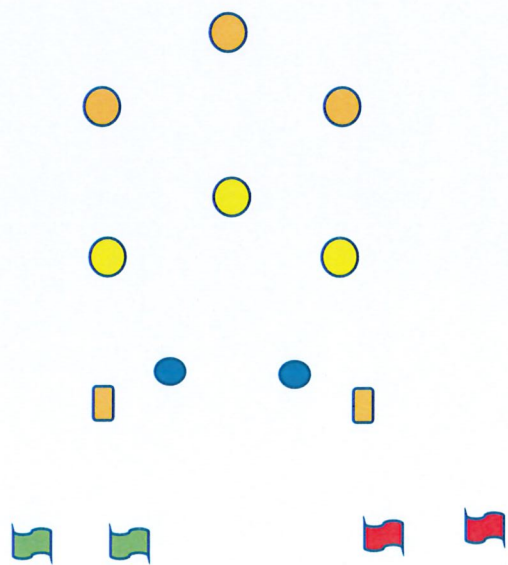
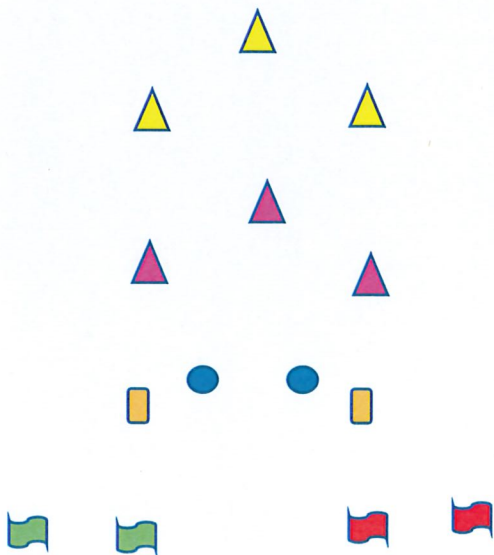
Parking: There is limited parking for participants, local free parking, & metered parking spots.

WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the 2026 USLA Mid-Atlantic Regional Lifeguard Championships, an athletic/sports event, which includes related events and activities, the undersigned:

1. Acknowledges and fully understands that each participant will be engaging in activities that involve risk and serious injury. This includes permanent disability, death, and economic losses that might result not only from their own actions, inactions or negligence, but the actions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or reasonably foreseeable at this time. Acknowledge, that mine or the minor's participation is voluntary and agrees to:
2. Assume any and all risks of personal injuries to myself or the minor and authorize the City of Ocean City, the Ocean City Beach Patrol, to render any medical treatment that may be deemed necessary for mine or the minors or to take me or the minor to any hospital. I (we) give authorization to a physician or surgeon for the minor or me to receive care and/or emergency medical treatment when necessary. If such medical treatment or hospitalization is required, I agree to pay all medical and hospital bills related here to, permanent or partial disability, or death and damages to myself or the minor or any property, caused by or arising from participation in the event or activity.
3. Release, waive, discharge, and covenant not to sue the United States Lifesaving Association, Mid-Atlantic Region of the USLA, the City of Ocean City, Ocean City Beach Patrol, their respective administrators, directors, agents, coaches and other employees or volunteers of these organizations, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability, loss, damage, claim, demand or cause of action against those attributable to myself or the minor's participation in the event or activity.
4. Agree that prior to my or the minor's participation in the event or activity, I or the minor and parents will inspect the facilities, equipment, and areas where the event or activity being conducted, and if either of us believe any of them are unsafe, will immediately advise the person supervising the event, activity, facility or area.
5. Grants the release right to film, photograph or video the participant during the event which extends to all phases of publicity, promotion and advertising.
6. Warrant that the minor or I is in good health and has no physical condition that would prevent the minor or me from participation in the event or activity.
