# **INSTRUCTIONS FOR CONCEALED CARRY PERMIT**

Concealed Carry Permit Application submissions are now completed online for both initial and renewal applications. Approved applications are due for renewal every two (2) years. Renewal applications can be submitted up to four (4) months before the expiration date. <u>Concealed Carry Permit applicants need to have been fingerprinted for firearms purposes in New Jersey and assigned an SBI number before they can apply for a Concealed Carry Permit. If you have never been fingerprinted for firearms purposes in New Jersey before, start with an application for an Initial Firearms Identification Card. Please see form for "FIREARMS APPLICATION PROCEDURE FOR FIREARMS IDENTIFICATION CARD & HANDGUN PURCHASE PERMITS" for instructions.</u>

If you have lived outside of the state of New Jersey in the last ten (10) years, please fill out <u>form SP-066</u> (Consent for Mental Health Records) and upload it to your application.

Once your online application is received and reviewed, you will be sent an email with instructions for your \$150 payment fee. This payment must be made by money order to "City of Ocean City". \*\*Email Instructions may take a few days – we also ask that you check your spam/junk folders for messages regarding your application\*\*

All other state fees will be paid online during the application process.

### WHAT WILL I NEED FOR SUBMITTING AN INITIAL CONCEALED CARRY PERMIT APPLICATION?

- SBI Number
- Upload of recent photograph (on a light background including head and shoulders)
- One (1) training record completed within the past two (2) years, instructor name, and qualification date. <u>Please refer to www.njsp.com >firearms information>forms to download for the latest</u> requirements. This also includes the proper firearms qualification form(s) and training requirements. The listed training form and qualification course will be the ONLY ones accepted. NO EXCEPTIONS!!!
- Personal Information: including Social Security Number and Driver's License Number
- Background Information
- For Armored Car Applicants: Uploaded Employment Letter (MUST APPLY THROUGH NJSP ONLY)
- Contact Information for four (4) <u>non-family related references (related by blood or law).</u>
- Information on handguns to be carried
- \$150 Application Fee (money order only)

# WHAT WILL I NEED FOR SUBMITTING A RENEWAL CONCEALED CARRY APPLICATION

- SBI Number, Last Name and Date of Birth for validation
- One (1) training record completed within past two (2) years, instructor name, and qualification date
- Any updates to Personal Information
- Upload of recent photograph (on a light background including head and shoulders)
- Background Information
- Any updates to Handgun Information
- \$150 Application Fee (Check or Money Order Only).
